We cannot solve the climate and ecological crisis without changing how we produce and consume food.

- Food accounts for at least a quarter of greenhouse gas emissions and is responsible for at least 70% of global deforestation, driving species loss
- A third of food produced is never eaten: a shocking squandering of resources threatening food security.







The challenge Is large but the benefits of addressing food waste are huge





Reducing food waste to address climate change

- Project Drawdown one of the most comprehensive reviews of global practical solutions to climate change, concluded that food waste reduction was ranked the solution with the **third** greatest global potential to reduce emissions
- The FAO estimates that the production of food that is wasted uses up "1.4 billion hectares of land – 28 per cent of the world's agricultural area"



Ultimate aim: Significant food waste REDUCTION



Reframing food waste from a moral scandal to an environmental issue



- National governments adopt binding statutory targets to reduce food waste by 50% from farm to fork by 2030
- National governments introduce legal requirement for businesses over a certain size to measure and report their company's food waste figures
- The European Commission decides in its 2023 in the revised Waste Framework Directive to make it compulsory for all member states to introduce mandatory targets to reduce food waste by 50% from farm to fork by 2030.

iffle Waitrose Hail Online

Waitrose is rated the 'worst' among supermarkets for its attempts to cut waste with Tesco coming out on top

- Waitrose ranked below all its rivals in survey by campaign group Feedback
- It scored just eight out of 32 in a four-category assessment
- Also poorly rated were Iceland, Marks & Spencer and Co-op but Tesco was best
- · Survey criticised stores for offers driving shoppers to buy more than they need

How can European government policies and regulation prevent food waste?



Transition from voluntary commitments to mandatory measures

- The RSPB conducted an analysis of the effectiveness of over 150 voluntary schemes, and found that
- Over 80% of schemes were found to perform poorly on at least one key measure
- Majority of schemes set unambitious targets, with many also failing to achieve 'unambitious' targets
- Many schemes were undermined by low rates of private sector participation and the resultant lack of a 'level playing field' for those participants seeking to improve their performance.
- Research found nothing to support the claim that voluntary approaches can be an effective alternative to regulation.



Transition from voluntary commitments to mandatory measures

A study on the relative impact of different policy interventions on household food waste across 44 countries found that "household food waste generation is 61 percent less in countries with defined legislative frameworks compared to those lacking, or having incomprehensive, ones" (Chalak et al., 2016) – by far the most effective measure among those studied.

What policies have been adopted at EU level to deal with food waste?



Waste Framework Directive

- Food waste targets: An aspirational target was set, but it is not binding for member states so they will most likely disregard it.
 - Calls for farm to fork food waste reduction, but it only calls specifically for 50% reduction at retail and consumer level - so many member states will interpret this as meaning they **do not need to aim for 50% reduction pre-retail at primary production, processing and manufacturing.**



Key Dates

- 2020 Member states will need to begin measuring their national food waste data annually from 2020 onwards – will have baseline data for targets (if not already).
- 2022 Member states will need to report national food waste data to the EU by 2022 (up to 18 months after the end of 2020 year)
- 2023 European Commission will review whether to introduce EU-wide mandatory food waste reduction targets
